## Grateful Patient Makes \$1 Million Donation To Hospital

*This Marks Foundation's Largest Outright Gift*

Ross MacNeill doesn't want the spotlight to shine on him and would prefer not to talk about his contributions to the Friends of The Moncton Hospital.

MacNeill, who turns 90 on March 1, would rather praise the medical staff at the hospital.

"They are all tops in my books," said MacNeill, who has been treated for heart issues and a stroke in recent years and a severe bowel blockage last fall.

"We're fortunate to have these people in Moncton," he added. "They are very professional and they know how to help people. I will always be grateful for what they have done for me."

MacNeill's gratitude was shown when he donated just **over \$1 million in listed securities** he and his wife Patsy had accumulated over many years.

"This has nothing to do with me," MacNeill said. "I figure if it helps their cause, it's something I want to do. I've heard a lot about the good work they have done and I hope this helps them out."

MacNeill grew up in Amherst, where he delivered newspapers as a schoolboy. He made 210 deliveries every week and earned a penny for each.

He looked to make money any way he could – from shooting pool to working as a caddy at the golf club. MacNeill also worked in the oil fields before spending a year at Mount Allison University in Sackville.

Following that, MacNeill landed a job with Household Finance and travelled throughout Atlantic Canada to collect on overdue loans.

"I learned a lot," he noted. "I never understood people who borrowed money and never intended on paying it back."

"In my life, I never spent money I didn't have. That's how I was able to save as much as I did. There's only one secret – spend less than you make."

MacNeill wound up moving to Moncton in 1962 and established his own bill collecting business – Credit-Aid Ltd. It remains in name only today, but is not active.

He and his wife "Pat", a Moncton native, have been

married 62 years and they have two daughters – one in Scoudouc and one in Surrey, B.C.

"I worked hard every day and it was probably 11 hours a day and seven days a week, but I was able to make a good life for myself and my family," MacNeill said.

"Through the hard work, I was able to save money. We only spent about 25 per cent of what I made on the job and the rest we saved."

MacNeill was inspired by the generosity shown by American financial giants Warren Buffett and Bill Gates, who are known for donating billions of dollars to various charities.

MacNeill said Doctors Serge Melanson and Bharathi Raja Chinnathurai have also inspired him.

"These are two amazing doctors who made an impact on my life. I hope I can help them and the other doctors at The Moncton Hospital make a difference in the lives of others like they made a difference in my life."

## Susan's Donations Come From The Heart

Listed Securities are a Great Gift Option

Susan Clarke's gifts to the Friends of The Moncton Hospital come from her heart and are intensely emotional.

Clarke, who has been a financial advisor to the Friends for about 15 years, has contributed generously to help fund improvements in the hospital's psychiatric inpatient unit.

Her mother – Diane Wood – was a nurse at the hospital for more than 25 years and most of that was spent diligently working with psychiatric patients. Clarke also has a brother who has struggled with mental health issues.

"My focus," Clarke said, "is based on enhancing the patient's experience in the hospital.

Work done on the outdoor green space off the psychiatric inpatient unit has created a better atmosphere for the patients and the staff," she continued. "It's a success story and I was happy to help with that project."

Clarke, Vice President and Wealth Advisor with RBC Wealth Management/RBC Dominion Securities in Moncton, wants to share her experience.

As part of the Friends of The Moncton Hospital's capital campaign, Clarke made a five year commitment to donate using her Royal Bank shares. It is much more beneficial to donate securities to the Friends as opposed to selling them and donating the cash. This avoids the capital gains tax and a receipt for the full amount of the donation can be used for tax purposes.

"I realized that I had a civic duty to do whatever I can to help the Friends of The Moncton Hospital and I was able to assist in the recovery of patients in a very special unit," Clarke noted.

She encourages others to do the same. The Friends of The Moncton Hospital has an easy process in place to receive gifts of listed securities. The donations are tax deductible and donors benefit from a charitable tax credit.

"It's a growing trend and more people are becoming aware of it," said Clarke, who has worked with RBC since 1991. "It can be arranged through any financial institution."

Donations from securities can be made at any time during your lifetime or through your will. There are also advantages to corporations for making this type of donation.

Susan mentioned "when donating through your will be specific and list the charity information in detail. If you have a specific purpose you wish to donate to you should discuss this with the charity in advance so they can receive the funds for the purpose you intended. Your will should provide direction to the executor to ensure your donation is used in the most tax effective way possible."

"Give the executor the power to direct the money to the place you chose it to go," she added. "The Friends of The Moncton Hospital has to be listed as a beneficiary."

"I would encourage everyone to donate in any way they can."

## Dynamic Moncton Couple Establishes Memorial Fund to Support Pediatrics

Peter Grainger hesitates for a couple of seconds then comes up with the best way to describe Ruth and Tom Barnes.

"They were kind people who were great listeners," said Grainger, who serves as the executor to the Barnes estate.

"They might have known a lot of prominent people and travelled all over, but their greatest joy was listening to other people," he continued.

"They loved to have people visit them at their home in Moncton's west end and tell them their stories – big and small. They were great listeners who listened to everyone."

It is with those traits of compassion and empathy and desire to always learn more that the couple established the **Ruth and Tom Barnes Memorial Fund**, as a key component of their wills.

Ruth was the proprietor of the Ruth Barnes Modelling Agency from 1966-2013. She co-ordinated fashion shows, advertising ventures and served as a mentor for thousands of young women. And in 2013, she was presented with the YWCA's Women of Distinction Award.


Ruth, 95, died in 2019. About a year later, Tom, 94, died at the Veterans Health Centre in Moncton.

Tom was an acclaimed photographer, who worked with his wife at the modelling agency. He was renowned for portrait work and he photographed countless weddings in southeastern New Brunswick. Tom had also served as president of the Albert County Historical Society.

"They were a dynamic couple because they were so vibrant in the community," said Pat Guitard, a long-time friend who held power of attorney for Ruth and Tom.

"They were life-long learners who always had kind words for others," Guitard said. "They wanted to learn from others while enriching the lives of others as well."

Money raised by the Memorial Fund, set up by the Friends of The Moncton Hospital, is used to support pediatric services at the hospital. Their daughter Jennifer was just nine years-old when she died of a rare bone disease.

"It was disheartening for Ruth, which is why she dedicated much of her work to young children after Jennifer's passing," Guitard said.

Grainger said the Memorial Fund is a fitting legacy for Ruth and Tom.

"They were not extravagant people," he said. "They were subtle and kind. They were people who cared for others and their presence will be felt in the community for many years to come."

# Endowment Honours Lynn's Wishes

Lynn Whalen's greatest joy and passion in life was becoming a mother to her three beautiful children. With the creation of the **Lynn Whalen Memorial Endowment Fund**, her legacy will live on long after her death.

Lynn's husband, Bill Whalen, says his wife of 36 years and mother of their three adult children — Katie, Matthew and Julia — died in January, three years after being diagnosed with ovarian cancer. She was 64.
